RESOLUTION

WHEREAS, the Airstream/Argosy division of Thor/Industries, Inc., has seen fit to start a new travel club called Airstream/Argosy Way of Life, and

WHEREAS, said club offers discounts to members on rallies and caravans as well as other discount offers, and

WHEREAS, said new travel club will collect dues and will have its own newsletter, and

WHEREAS, the president of Airstream, Inc., is a member of the International Board of Trustees of Wally Byam Caravan Club International, Inc., and is the person responsible for starting said new club, now therefore,

BE IT RESOLVED, that Delmarva Unit WBCCI goes on record as viewing the start of said new club as detrimental to WBCCI and as bound to affect adversely membership of WBCCI. It is the view of this unit that the new club has been organized to enhance the sale of Argosy trailers and thus the profits of the Airstream division of Thor Industries.

BE IT FURTHER RESOLVED, that the president of Airstream, Inc., be removed immediately from the Board of Trustees of WBCCI. The rationale is that no person willing to damage WBCCI should be on the International Board of Trustees.

Publicizing a club which will undermine WBCCI (see pages 38 and 39 of October 1987 issue) should not be a function of the Blue Beret.

BE IT FURTHER RESOLVED, that WBCCI should cease to accept funds from Airstream, Inc., relative to the sale of Airstreams to WBCCI members. The funds are really paid by the Wally Byam member who buys the trailer or motorhome as the "gift" is really figured into the price of the unit purchased.

BE IT FURTHER RESOLVED, that Delmarva Unit members go on record as favoring a dues increase to compensate for funds lost as a result of dropped Airstream "gifts".
