## SWEETWATER RALLY

Thursday July 17 to Sunday July 20, 2008 the SNU will hold it's rally at Sweetwater Summit, a dispersed Forest Service, near Yerrington. The area is located on highway 338 in Nevada, which comes out of Bridgeport as California hiway 182. If you are heading north on Nevada 338, at the Sweetwater Summit there is a large parking area to the right with a weather gathering station at the south end. From the southern end of the parking area, there is a short dirt road that goes behind a small knoll where the area flattens out and is an excellent place for a large group and large rigs. There are lots of good places for hikes and dirt bike rides. Hwy 338 is a known bicycle route. The elevation is right about 7,000 ft so we will probably have cool nights and warm days. There is no water or other facilities so this is a bring it in, take it out type rally site.


#### RALLY SCHEDULE
